2. Approval of Minutes of the 2015 Meeting of the Board of Directors

The Minutes of the 2015 Meeting of the Board of Directors of the Society were approved.

3. Report of the Nominating Committee and the Election of Officers and Executive Committee Members (David Clark)

David Clark, Chair of the Nominating Committee, reported on nominations for the Society's officers and executive committee members. There were no nominations from the floor. The results of the elections were as follows:

4. Report of the Ad Hoc Committees on Outreach (Richard Albert, Gary Bell and Maximo Langer)

Written reports from the Ad Hoc Committees on Outreach for Social Science, on Outreach for Asia, and on Outreach for Latin America, were distributed prior to the meeting. The chairs of the committees for Social Science, for Asia, and for Latin America (Richard Albert, Gary Bell and Maximo Langer) orally summarized the recommendations of their committees' reports.

5. Board of Directors Meeting Suspended – Meeting of the Board of Editors of the American Journal of Comparative Law Convened – Report of the Editors-in-Chief (Helge Dedek and Franz Werro)

The Directors meeting was suspended and the meeting of the Board of Editors of the American Journal of Comparative Law was convened at 11:00 a.m. Helge Dedek and Franz Werro, as Editors-in-Chief, reported on the Journal, including distributing a written annual report for the Journal. The Editors-in-Chief reported that submissions of good quality articles remained steady (while there was a decline in submissions of poorer pieces to the Journal); that the Journal had published very diverse pieces, including two symposia and an innovative book review mini-symposium; and that there was a noteworthy increase in the Journal's JCR impact factor (to 1.721). They also reported that Richard Albert had taken the post of Book Review Editor, while James Feinerman resigned as co-Editor-in-Chief because of additional administrative responsibilities at his law school, and they acknowledged the work of the editorial board. Administratively, it was business as usual with stable income and cost. Publication of the Journal by Oxford University Press will begin in January 2017.

6. Meeting of the Board of Editors of the American Journal of Comparative Law Adjourned--Directors' Meeting Reconvened

President Gerber reconvened the Board of Directors meeting at 11:10 a.m.

7. Report of the Treasurer (Mortimer Sellers)

The Treasurer presented his annual report on the finances of the Society---the final financial report for January 1 to December 31, 2015, having been distributed to the members prior to the meeting. The Treasurer reported that the finances of the Society are in good order. The Treasurer briefly discussed expected changes in the revenue from the Journal resulting from the new publishing arrangement with Oxford University Press, as well as changes in revenues from endowment and membership. The Treasurer suggested that the President consider forming an investment committee and a grants committee and consideration be given to the use of endowment income to fund initiatives resulting from the suggestions of the three ad hoc committees on outreach. The Treasurer stated that the proposed budget for 2017 remains the same as the budget for 2016. For the next year, the Treasurer recommended that the Society continue charges for membership and expenditures at the following levels:

1. Dues for Sponsor Members for 2017 remain at \$700;

2. \$10,000 donation to a sponsor member for the services of the Executive Assistant and for other costs;

3. Up to \$3000 be paid to support the 2017 annual dinner;

4. Up to \$2000 be paid for the expenses of travel to the 2017 annual meeting by the recipient of the Lifetime Achievement award.

5. Dues be paid to the American Council of Learned Societies in the amount of \$990;

6. Dues be paid to the International Association of Legal Science in the amount of €1000;

7. Up to \$1,000 to be paid in reimbursement for travel to the ACLS and the IALS;

8. The maximum reimbursement for each Sponsor member represented at the 2017 Annual Meeting be set at \$600;

9. Up to \$3000 be paid to recipients of prizes for scholarship authorized by the Society;

10. Up to \$3000 be paid for reimbursement of expenses for participation in the 2017 Comparative Law Works-in-Progress Workshop;

11. Up to \$7000 be paid for reimbursement of expenses for participation in and other costs of conferences to be sponsored by the Younger Comparatists' Committee;

12. Up to \$1000 be paid for website maintenance;

13. Up to \$1,000 for technology support and enhancement;

14. Up to \$1500 to be paid for accounting services.

A motion to adopt the Treasurer's Report and Recommendations was moved, seconded and adopted.

8. Report of the Annual Meeting Program Committee (Hannah Buxbaum).

Hannah Buxbaum gave a brief report on behalf of the Program Committee and thanked the members of the Committee.

9. Report of the Younger Comparativists' Committee (Ozan Varol)

Ozan Varol, chair of the Younger Comparativists' Committee, made available a written report detailing various past and upcoming events. In terms of future events, he reported that the committee's 2017 conference will be held for the first time abroad, at Koc University in Turkey; in 2018 the conference will be at Case Western University; and in 2019 at McGill University. He also described the Committee's new members pipeline initiative.

10. Report of the Prizes Committee (Fernanda Nicola)

Fernanda Nicola, chair of the Prizes Committee, reported that the committee voted to award, as co-winners, the Yntema prize to Philomila Tsoukala and Yan Lin.

11. Continuing and New Business

David Clark expressed concern about the Society's website.

12. Announcements

Tim Sellers announced the start of the ASCL book series published by Cambridge University Press and stated that he welcomed proposals for either monographs or edited volumes for the series. There were brief announcements regarding the next International Comparative Law Congress (Franklin Gevurtz), the workshop for comparative law papers (Maximo Langer), and next year's Society meeting and conference at American University School of Law in Washington D.C.

13. Adjournment

There being no further business, it moved, seconded and approved that the meeting be adjourned at 11:40 p.m.
