2. Approval of Minutes of the 2016 Meeting of the Board of Directors

The Minutes of the 2016 Meeting of the Board of Directors of the Society were approved.

3. Report of the Nominating Committee and the Election of Officers and Executive Committee Members (David Clark)

David Clark, Chair of the Nominating Committee, reported on nominations for the Society's officers and executive committee members. There were no nominations from the floor. The results of the elections were as follows:

4. Report of the Treasurer (Mortimer Sellers)

The Treasurer presented his annual report on the finances of the Society---the final financial report for January 1 to December 31, 2016, having been distributed to the members prior to the meeting. The Treasurer reported that the finances of the Society are in good order. The Treasurer further reported that while the endowment is doing well, the President has formed an investment committee to review the Society's strategies for investment of its endowment funds. The Treasurer stated that the proposed budget for 2018 remains largely the same as the budget for 2017, except primarily for increased reimbursement of travel expenses for attending the Society's 2018 annual meeting held at the International Congress of Comparative Law in Fukuoka, Japan. For the next year, the Treasurer recommended that the Society continue charges for membership and expenditures at the following levels:

- 1. Dues for Sponsor Members for 2017 remain at \$700;
- 2. \$10,000 donation to a sponsor member for the services of the Executive Assistant and for other costs;
- 5. Dues be paid to the American Council of Learned Societies in the amount of \$990;
- 6. Dues be paid to the International Association of Legal Science in the amount of €1000;
- 7. Up to \$1,000 to be paid in reimbursement for travel to the ACLS and the IALS;
- 8. The maximum reimbursement for each Sponsor member represented at the 2018 Annual Meeting in Fukuoka be set at \$1400;
- 9. Up to \$3000 be paid to recipients of prizes for scholarship authorized by the Society;
- 10. Up to \$3000 be paid for reimbursement of expenses for participation in the 2017 Comparative Law Works-in-Progress Workshop;
- 11. Up to \$7000 be paid for reimbursement of expenses for participation in and other costs of conferences to be sponsored by the Younger Comparatists' Committee;
- 12. Up to \$1000 be paid for website maintenance;
- 13. Up to \$1,000 for technology support and enhancement;
- 14. Up to \$2000 to be paid for accounting services.

A motion to adopt the Treasurer's Report and Recommendations was moved, seconded and adopted.

5. Board of Directors Meeting Suspended – Meeting of the Board of Editors of the American Journal of Comparative Law Convened – Report of the Editors-in-Chief (Helge Dedek)

The Directors meeting was suspended and the meeting of the Board of Editors of the American Journal of Comparative Law was convened at 10:40 a.m. Helge Dedek, on behalf of both Editors-in-Chief, reported on the Journal, having distributed a written annual report for the Journal. He discussed the transition to publication by Oxford University Press and stated that issues raised by the transition were being addressed. He answered questions concerning the backlog of articles in press and posting of articles in on-line databases.

6. Meeting of the Board of Editors of the American Journal of Comparative Law Adjourned--Directors' Meeting Reconvened

President Curran reconvened the Board of Directors meeting at 10:50 a.m.

7. Report of the Annual Meeting Program Committee (Maximo Langer).

Maximo Langer gave a report on behalf of the Program Committee. He stated that there was a change in the third participating individual and school involved in the annual workshop for comparative law works-in-progress. The next workshop will be held at Princeton University.

Upon the Committee's recommendation, a proposal to hold the Society's 2019 annual meeting at the University of Missouri, Columbia, and a proposal to hold the Society's 2020 annual meeting at the Boston University, were moved, seconded and approved.

8. Motion to Amend Bylaws (Vivian Curran)

A motion to authorize the President to make non-substantive amendments to the Bylaws, changing Bylaws' use of gendered pronouns, was made, seconded and approved.

9. Report of the Prizes Committee (Timothy Webster)

Timothy Webster reported on behalf of the Prizes Committee that this year's Yntema Prize was awarded to Maya Berinzon and Ryan C. Briggs for their article *Legal Families Without the Laws: The Fading of Colonial Law in French West Africa*.

10. Report of the Younger Comparativists' Committee (Virginia Harper Ho)

Virginia Harper Ho, chair of the Younger Comparativists' Committee, made available a written report detailing various past and upcoming events, and summarized some of the highlights of this report.

11. Report of the Ad Hoc Committee on Revenue Splitting (John Reitz)

John Reitz presented the report of the ad hoc committee appointed to draft a statement of principles for distributing the revenue generated by the publishing contract with Oxford University Press (the Committee). The other Committee members were Helge Dedek, Mathias Reimann, and Franz Werro. The Committee thought it important to underline to the Society that the Committee does not expect to see large revenues from the OUP contract, especially in the early years of the contract, because of the Journal's deliberate choice to pick a publisher who agreed to smaller price increases for the Journal

subscriptions in order to maximize access to the Journal. The Committee's report was presented in the form of a statement of the principles the Committee proposes, a copy of which is attached to these minutes. The report is premised on the principle that the first priority for use of the funds from OUP should be to try to make the Journal self-sufficient. (The Journal currently depends on subsidies from both host schools of up to \$25,000 per year.) Accordingly, the Committee's report recommends that:

After taking care of any expenses not covered by the host school subsidies, the next priority should be reimbursement of the host school subsidies, then replenishment of the Journal's reserves to the level that would cover expenses to operate for one year without subsidy if the OUP contract should be terminated, with the balance, if any, to the Society.

The part of the proposed principles dealing with procedures also include the creation of a Joint Audit Committee to determine how the funds should be distributed each year according to the proposed principles.

It was reported that the Executive Committee had reviewed the Ad Hoc Committee's report and approved the proposed principles. John Reitz moved the adoption of the proposed principles as set forth in the attached statement. The motion was seconded and after brief discussion, the motion passed.

12. New and Continuing Business

There was no other new or continuing business.

13. Announcements

Tim Sellers briefly reported on the progress of the ASCL book series published by Cambridge University Press and stated that he welcomed proposals for either monographs or edited volumes for the series.

13. Adjournment

There being no further business, it moved, seconded and approved that the meeting be adjourned at 12:40 p.m.
